Program / Project Description:

Each year the 5p- Society holds a family conference for its individuals with 5p- Syndrome (also known as Cri du Chat Syndrome) and their families. In order for the parents to get the most out of the conference we offer child care, at no cost, during the day. It is getting increasingly more difficult to find volunteers to assist with this major and important part of the conference. There are organizations who we can hire to come to the conference and set up, coordinate workers, coordinate activities, and run mini camps for the individuals with the syndrome and their siblings. The cost for this runs anywhere from \$18,000 to \$25,000 for the amount of individuals that need child care every year. We just do not have the excess money that is raised to hold the conference to pay for the services of one of these companies. Our conference runs approximately \$65,000 and this pays for all meals and activities. Families are asked to fund-raise money to help pay for these expenses. We would like to eliminate the need for families to have to fund raise to lessen the burden and reduce barriers to those who want to attend.

Evaluation Plan:

If granted, the 5p- Society would need to evaluate the effectiveness and success of hiring an outside entity to conduct child care for the conference. This would be done by survey by parents who utilize the service for their children. The board of directors would also need to evaluate the cost to ratio of how many individuals use the service versus the total cost and figure out a per person cost. This will help determine the effectiveness of hiring an outside company to conduct these services.

Plans to sustain project beyond the term of this request:

If successful, and the desire to hire an outside company to conduct these essential duties for the conference, the board of directors would then need to determine the approximate cost per person and make a decision to either seek additional grants to cover the cost of these outside services, or add these services to the cost of registration to attend the conference. Alternatively, the board could solicit its membership to raise funds to assist in paying for this services.
