Program / Project Description:

AHIA provides financial support (grants) to brain injury survivors to positively impact and improve their lives. The AHIA grant program has three primary grant request categories: Education Assistance, Assessable Housing Modifications, and General items such as specialized equipment. This year (2023) we have seen a significant increase (3x) in requests for assistance, mostly in the area of funding to help with the cost of modifying homes (often bathrooms and entryways) to make them more assessable and safer. With our organization's increased focus, passion and efforts, we will continue and possibly increase our funding to support the special needs of survivors of brain injuries that have physical and cognitive disabilities. Through Sept. 2023, we have funded or have committed to funding for sixteen survivors and their families. We currently fund our grant program 100% with internal funds. To maintain and hopefully expand our level of financial support to our targeted community, we are seeking external sources, such as the Gordon Hartman Family Foundation, to assist us in funding a portion of our survivor grant program.

We believe that the AHIA grant program aligns with the mission and intentions of Gordon Hartman Family Foundation and its support of non-profit organizations such as AHIA for Bexar County and surrounding counties.

Evaluation Plan:

Any funds granted and received pursuant to this Funding Application would be restricted to the 2024 AHIA grant program for its targeted community; individuals with moderate to severe acquired brain injuries that have special needs due to their cognitive and physical disabilities. AHIA can provide information throughout the year that shows what the funds were used for.

Plans to sustain project beyond the term of this request:

AHIA has been in existence for over 40 years. It has experienced challenges as well as very position outcomes over the years and has maintained its mission and support of its targeted community, individuals with moderate to severe acquired brain injuries and their family and caregivers. The AHIA survivor Grant program is one of the core tactics in pursuit of meeting its mission and objectives. Other core tactics include providing emotional and social support, increasing awareness, advocating for needs, interacting with the community and gaining and sharing knowledge and information regarding resources.

Our plans are to grow the AHIA survivor grant program, while balancing the financial resources with the other key tactics of the organization. Additional funding from external sources would greatly enhance our ability to maintain and grow the financial support to serve the targeted community.
