Program / Project Description:

Adapt A Vet is requesting funds to assist with the purchase of a "tiny" home for a Disabled homeless Veteran. This Veteran was severely injured after he encountered an IED blast which took his left hand and a portion of his forearm and left his torso deeply scarred. He suffers from PTSD as well and the stress of not having a place of his own which can be a triggering mechanism that flares up his PTSD. This home will be placed on a ranch in Seguin, Texas where he currently works. The location is equipped with Water, Electricity and Sewer. The ranch of which the home will be placed for the Veteran is owned by a local Veterinarian. In exchange for living on the property, the Veteran will be assisting the owner with the day to day tasks of the whitetail breeding operation. This Veterinarian who is friends with the Veteran has had him living on his property for the past 2 years and has offered the Veteran a permanent place to live if in fact he is able to obtain some type of dwelling. The Veterinarian, at his sole expense, has offered to pour a slab and has the plumbing and electric on the property. Giving the Veteran a home will allow him to continue his mission helping other homeless Veterans all over the U.S. instead of worrying about a mortgage payment or not having a place to call home so his daughter can come visit him. This Veteran has been helping so many other Homeless veterans by using what little income he has instead of focusing on securing a place of his own. One of our partners, Home (Team) Depot, will be installing a wood deck once the home has been placed on the property. It is our goal with all of the Veterans we help to show them "What Freedom Feels Like In Their Own Home".

Evaluation Plan:

The objective of Adapt A Vet is to provide disabled Veterans with the opportunity to live comfortably among society outside of their previously structured military lifestyles. Adapt A Vet has taken on this role of assisting disabled Veterans nationwide in order to give back to those who fought for our country's freedom. By attending to our Veterans, this provides means of safety, security and a place that is truly their own. By granting this disabled Veteran a place of his own, he can continue to help others as well as be given a renewed sense of self-worth and need. He will continue to work by assisting with the deer breeding program in exchange for living on the Veterinarians property; this allows for the Veteran to utilize an alternate route of coping with his PTSD all the while providing assistance maintaining the deer population. This opportunity extends far beyond just one disabled Veteran, but impacts those who cross his path including the Veterinarian, the deer population, and most importantly other disabled Vets the recipient continues to selflessly aid.

Plans to sustain project beyond the term of this request:

Manufacturer to donated a portion of the cost of the tiny home. We have a Patriot Drum raffle campaign that ends 12/31/20 to raise funds in addition to a Christmas fundraiser.
