Program / Project Description:

CPATH's Pediatric Medical Equipment Closet Program orchestrates the exchange and reuse of durable pediatric medical equipment for anyone with a need, at no cost. CPATH's population can choose from a comprehensive selection of gently worn equipment such as wheelchairs, walkers, standers, seating systems, lifts, medical tubing and feeding supplies, and bath equipment. Donations are thoroughly inspected and repaired by qualified, experienced staff before releasing items for distribution to ensure safe and appropriate use. Since medical equipment is often denied by insurance, includes costly co-pays, and/or involves lengthy timelines for approval, the CPATH Equipment Closet Program provides Central Texas individuals and families in need with immediate access to equipment.

The initiative launched in March 2019 as an affordable and efficient solution to address a common critical need experienced by the families CPATH serves: inadequate access to expensive medical equipment that their children need in order to thrive. Since then, it remains unique to the Central Texas area and has facilitated over 2100 pieces of equipment worth 2.2 million dollars, back into the community.

The program is currently limited by physical space and anticipates an increase in lease costs for 2024. With additional funding support CPATH will facilitate an increase in the amount of equipment the program provides and effectively improve the quality of life for more Central Texans.

Evaluation Plan:

The CPATH evaluation program consists of the described set of metrics and organized feedback for each of the following areas:

Plans to sustain project beyond the term of this request:

Once the grant period expires, we will continue to seek support through foundations, individual donors, and our annual fundraiser, "Light the Path." In addition, we will continue to identify local businesses such as therapy clinics, hospitals, and insurance companies who pull their resources to help support our mission through sponsorships year after year. We also plan on strengthening our outreach efforts while fostering relationships with new and existing community partners to help raise increased awareness about cerebral palsy throughout the immediate Central Texas area and beyond.
