Program / Project Description:

We are requesting funding to support our day habilitation program, Adult Life Enrichment (ALE). For the individuals with IDD we serve through Adult Life Enrichment, the ALE program is their primary connection to community integration, giving opportunities to develop and practice life and social skills at The Arc's facility, during community outings (post-pandemic), and during service opportunities.

Each day, our team delivers five hours of thoughtfully designed programming intended to address the mental, emotional, physical, and social needs of adults with IDD. Topics include functional life skills (how to clean the house, do the dishes, communication/relationship skills, etc.), enrichment activities like art club, and health and wellness (fitness classes, nutrition workshops, etc.).

In addition to supporting our participants, the ALE program supports their caregivers as well. Most participants' caregivers work part- or full-time and many have other caregiving responsibilities. For them, The Arc is an essential support that enables wage-earning activity and respite.

Margaret, a parent of a longtime ALE participant, recently wrote,

"Our youngest son, Matt, first started in the after-school program at age 12. For the past 27 years, Matt's participation in The Arc's day programs has enriched his life and ours. Knowing that Matt spends his time with friends and compassionate caregivers allows me to be active and productive in my career."

Of the 150 ALE participants we serve annually, 64% are classified as economically disadvantaged and the majority receive Social Security or disability income. 45% are Hispanic, 42% are Caucasian, and 10% are African American.

Evaluation Plan:

A cornerstone of the ALE program is community integration, whether through social outings or volunteer engagements. In normal times, our staff lead over 80 of these outings per month, supporting the latest thinking from HHS regarding the central importance of community integration for individuals with I/DD (Transition of Day Habilitation Services-January 2021).

We will continue to provide virtual community integration opportunities until it is safe for us to resume in-person community activity; we will also continue tracking virtual participant numbers and sharing this information with The Arc's CEO and ALE Program Committee members.

The pandemic has made painfully clear how essential adequate care support- whether for children, older adults, or adults with disabilities- is to the functioning of our families, community, and economy. The Arc has long kept our daily fee for service rates low for private paying ALE families. Programs like this will only stay affordable by subsidizing earned income with contributed income from foundations and government. We are currently creating survey questions intended to collect information on the specific ways the ALE program supports our families' caregivers.

Plans to sustain project beyond the term of this request:

With over 100,000 individuals living with a cognitive disability in Bexar County alone, the need for quality, consistent community supports for individuals with IDD is substantial. We are committed to accessibility and recognize this unfortunately also means dealing with an ever-widening gap between earned revenue and program costs, as relative state reimbursement rates continue to decline and programmatic costs stay consistent or increase. Nevertheless, we continue to work with The Arc of Texas and others to bring more visibility and support to the needs of individuals with IDD and their families.

Because we believe strongly we will continue to have a funding gap between earned income and program cost, we operate an aggressive, consistently successful fundraising program. Our administrative team works hard to secure funding from local and national foundation, corporate, and individual partners. Our strategic plan calls for continued focus on diversification of funding streams, with more emphasis on individual giving and planned gifts. As long as the need for quality adult day habilitation exists, we will keep advocating for this critical community service via additional funding requests.
